DISTRICT PROGRAM EVALUATIONS

4th Grade - Beth Williams spoke. There are 50 students in 4th grade, 16 of those kids are in Title. Everyone seems to be making gains with reading compared to where they were at. 34/50 students are at or above reading level.

5th Grade - Kolby Lawson & Sarah Owens spoke. 37 kids in 5th grade. 58% were below grade level for reading at the start of the year, and that number has now dropped to 30%. Students reading at or above 5th grade level have changed from 36% to 66%.

JH Track - Keith Smith spoke. This is his first year doing track. 24 boys and 20 girls are out. Trying to implement the same drills as high school so they can give them several years of data to see their progress. He believes they should have a competitive team.

HS Track - Melody Dickerson spoke for girls track. She has some new kids trying pole vault. There are 5 Seniors. They look at times for practice/meets each week to show growth. Brian Mayer spoke for boys track. 25 boys are out. They are still practicing the same way as before by focusing on technique, conditioning, and physical ability. Track is beneficial for every sport.

Golf- Carson Quint spoke. He has 9 golfers out. He's focusing on each individual player and their needs since several of them are new to the sport.

Baseball - Blaine Robinson spoke. They had 3 All-State players last year. 23 players are back this season, 7 are seniors, and 6 are dual sport athletes. He would still love to have a JH baseball program considered.

Banking Bid Renewal - Received bids from all three banks in town. Current interest for our main account is 1.5% and 0.35% for scholarships, etc. All three explained ways to invest and make money. The biggest difference was the interest rates for the accounts. First Interstate gave a 1 year bid, 2.75% interest for our main account, no interest for scholarships, etc. Farmers bank offered a 1, 2, and 3 year bid. Interest is based on the money market rate. They thought rates would stay steady. 2% plus the index amount of what's in our account, (4.15% with \$4 million) (3-4 million 3.65%). Other accounts go 0.5% for interest.

Putnam County State Bank used the treasury bill rate for our interest for a 3 year bid (5.49%). They will use that on all accounts and it could fluctuate every month. This was Kathy's recommendation to use.
